**0. Application; Fares; Expenses**

The fares in this deal apply to One Way, Round Trip, Circle Trip and Open Jaw journeys. This special fare offer herein is an Addendum to the AGREEMENT between the Parties and all other terms and conditions set forth in the AGREEMENT shall remain in effect for the Term of the AGREEMENT.

Base Commission does not apply. These commissions are strictly for sales of **USA or Canada** market origin. All other published fare rules and conditions apply.

Commissions from RNAM (Region North America: USA, Canada, Puerto Rico, US Virgin Islands) to Australia/ New Zealand are aligned with O502 QF/AA Joint Agency Contract.

**When using private fares, the respective private fare rule and conditions prevail.**

**4. Flight Application**

Travel not permitted on any FJ services or QF marketed/FJ operated services.

Travel not permitted on any TN services or QF marketed/TN operated services.

Between North America-AU/NZ: Valid on QF flight numbers only as per permitted routing (includes QF marketed/AA operated services.)

Domestic Canada, US and transborder travel permitted on all filed Canadian and US add-on carriers.

Domestic AU/NZ and trans-Tasman travel permitted on QF operated and QF\*/JQ operated flights only as per fare rule and routing.

**When using private fares, the respective rule and fare conditions prevail.**

**5. Reservation/Ticketing**

Tickets must be issued by authorized agents only.

**1101529** MUST be entered into the Tour Code Box.

**UQ** MUST be entered in the ticket designator field (automated in private fares).

Tickets to be issued on 081, no exceptions nor adjustments for tickets issued otherwise.

Tickets may show either CAD or USD, as is applicable to the country of origin/point of sale.

Private fare basis reflects the published fare basis except that the permitted percentage discount is appended to the end.

**When using Private Fares, the respective private fare rule and conditions prevail.**

When using Private Fares, the CRS will display the net fare. No further discounting permitted.

When using Published(Public) Fares, the CRS will display the gross fare. Discount by applicable percentage.

**10. Constructions & Combinations**

Combination with US, CA, AU and NZ add-ons permitted, subject to fare rules. Combination of more than one fare under this deal permitted. Combination permitted with other fares (QF fares and fares of other carriers) which themselves permit combination. When combining fares, appropriate commission for each component may be claimed.

**Note:**

**Walkabout fares (-WALKUS/-WALKCA) and -XI fares (-SXI and -PXI) must be issued on the same ticket as the international.**

When using private fares, the respective private fare and rule conditions prevail.

Definition:

'Issued in Combination' means allowable fares may be issued on the same ticket.

'Issued in Conjunction' means tickets issued separately. All other published fare rules and conditions apply.

**18. Ticket Endorsements**

Tickets must be endorsed with "NONEND/REF/REROUTE W/OUT REF ISSG OFFICE".

**19. Childrens and Infant Discounts**

Subject to published/private fare rules and conditions, children discounts are permitted. Infant discounts are not permitted.
