For CA departures, AC/WS are the only interlines permitted, and considered online For US departures, China domestic travel must be via CA/SC/ZH numbered & operated flight, or any CA/SC or CA/ZH codeshares.
<b>SALES APPLICATION</b>	The sale and ticket issuance must originate and be processed in Canada. All tickets issued under this contract must be validated using CIP999.
<b>QUALIFYING ITINERARIES</b>	One-Way, Round-Trip and Open-Jaw itineraries are permitted. For use by Canadian travel agents ONLY; POS Canada.
<b>QUALIFYING PASSENGERS</b>	ALL types (Except infants; Infants please use published rate)
<b>COMMISSION APPLICATION</b>	Commission may be claimed on everything within the fare box including surcharge and navigation fee. All tax box (including surcharges) are non-commissionable. No commission applies to infant tickets.
<b>COMBINATIONS</b>	The lowest rate of the transpacific segments (between Canada and Mainland China) applies to the whole ticket. Most restrictive rules apply including FFP accrual.
